Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 12. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	The school has cordoned the area by building a concrete wall where the HT line is passing. The school should not use that land for any activity of the school nor use it for any other purpose. An undertaking to this effect be submitted in the SARAS portal.
3	Only one table is placed in the Maths lab. The school should develop the Maths lab as per the SoPs issued by the board vide Circular no. 11 dated 04.10.2022 and submit the compliance through videography within 3 months on SARAS portal.
4	The school has converted one cubicle as toilet for CWSN in boys and girls washrooms, but the cubicles are too small for a wheel chair/walker to access. There is no provision for CWSN toilet on second floor and proper permanent signages are not available. The ramp at the entrance of the washroom is not friendly. The school should construct the CWSN toilets separately for boys and girls on every floor as prescribed in the RPwD Act 2016 and Circular no.5 dt. 6.3.2023 issued by the Board and submit the compliance through videography on the SARAS portal within three months.
5	The school should appoint Special Educator with qualifications laid down by the board and minimum requirements laid down by Rehabilitation Council of India and submit the compliance within 3 months on SARAS portal.
6	The school should maintain school accounts as per board norms and submit the compliance within 3 months on SARAS portal.
7	The school is required to apply for upgradation to Secondary or Senior Secondary level within 5 years from the date of grant of Middle Class Syllabus.

8	The school has a composite lab of Biology and Chemistry but not Physics.No seating and safety measures like exhaust and fire extinguisher are seen.The school shall upgrade the composite lab as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
9	The school has placed a fabricated steel ramp at the entrance of the building which is seen as slippery and unsafe for CWSN.The school shall construct a concrete ramp at the entrance within 3 months abd submit compliance on SARAS with videography.
10	The school's contention that building safety covers the hall is not acceptable, as the building safety certificate only certifies the structural stability of G+1 building.The school shall get a separate structural stability certificate and fire safety certificate for the hall which looks dilapidated , within 3months and submit compliance on SARAS.
11	The school shall ensure the training of its teachers with CoE Bengaluru within 3 months and submit the compliance.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
